## Background

The CRU confirmed in <u>CRU202277-202223-PSO-Final-Decision-Paper.pdf</u> that the PSO levy for the PSO Year 2022/23 is negative. It also confirmed that as an interim arrangement the PSO Levy would be set to zero until an enduring mechanism which would enable payments to customers would be in place.

ESB Networks has engaged with CRU and EirGrid to develop a process which would facilitate a PSO Payment to retail suppliers for distribution to final customers.

The CRU PSO Invoicing and Collection Procedures Information Paper describes the highlevel payment process relating to PSO levy and PSO Payment as appropriate.

This MDR describes the enduring ESB Networks- Retail Suppliers PSO Invoicing process for when a PSO Payment applies.

## **Proposed Solution**

To facilate PSO Payments to final customers ESB Networks will calculate the PSO Payment due to a supplier based on customers connected to the Distribution network and registered with that Supplier at the month end (in accordance with the PSO Invoicing and Collection Procedures Information Paper and CRU publication of applicable PSO rates).

ESB Networks will then issue a credit note with detailed backing documentation to the supplier and subsequently transfer the relevant funds to the supplier in accordance the PSO Invoicing and Collection Procedures Information Paper

Changes are required to MPD34 DUoS, Transaction and PSO Payment Process and DUoS, Transaction and PSO Payment Process Briefing Paper to include reference to PSO Payments.
