Reason for Request	
<b>Background</b>	
<p>Within the retail market, customer agreements must be in place before a 010MM can be submitted. In addition, a ten working day cooling off period must have been completed prior to the submission of the 010MM. Currently there is no definitive facility within the market to validate the existence of a customer agreement and the ten working day cooling off period. The supply agreement flag contained within the MIG for meter registration assumes the existence of the customer agreement. At the request of UR, changes to the 010MM are required to capture the associated customer agreement details.</p> <p>This request will be scheme impacting and it is planned to implement a manual workaround for this solution until a schema release can be implemented.</p>	

Proposed Solution
<p>It is proposed to use the current interim solution to register the date of the customer agreement. Suppliers will be required to send a pre-registration message via the webservice which will contain the date of the customer agreement.</p> <p>Validation will then take place to:</p> <ol style="list-style-type: none"> <li>1. Determine that the ten working day cooling off period has been maintained between the date of the customer agreement and the submission of the 010MM</li> <li>2. Confirm that the date of the customer agreement is not more than 6 weeks prior to the date of the submission of the 010MM.</li> <li>3. Confirm that the customer agreement is not submitted more than twice. An unique identifier will be required for each customer agreement.</li> </ol> <p>A 102 R rejection message will be issued with a new data code in the RejectReasonCode field which will indicate that the timescales have failed validation.</p>

The following data code values will be added to the Reject Reason data item in the co-ordinated baseline:

- ICW – Inside Cooling off Window
- OAW – Outside Agreement Window
