- NPA Disconnection Moratorium begins on 8th December 2025 to 16th January 2026.

 will be ongoing over the next number of weeks and a report will be issued with the analysed findings
 in due course.
- ESB Networks recognises that a number of queries were received when link was first issued, these





queries and feedback will be taken on board going forward.

Market Participant LTNA Contacts

- Point of contact requested for each MP and action will be left open until contacts have been received.
- LTNA files were issued in early November dated up to 31st October 2025 and are due to issue again in March 2026.
- Important to review the files against internal supplier records to reduce LTNA volumes and prioritise reason codes 70 or 71.
- Sites with no engagement for number of years, suppliers are requested to update contact details where possible via 013MM and meter readings via 210MM. Date on a 210MM can not be in the past or the message will reject. If access arrangements are known, please provide these to ESBN.
- ESB Networks also request suppliers to review sites that are eligible for de-registration. Sites can be de-registered via the 021MM. MPD21 on the RMDS website will provide further detail on this process.
