# 6. Retail Market Design Update

S Hudson gave the RMDS update.

D McBride stated Electric Ireland will support with the stipulation that they not need to action until 2027.

J O'Dwyer stated this would need to be taken offline.

I Mullins asked if that was an industry stipulation or just for Electric Ireland.

J Burke advised on other requirements on behalf of Electric Ireland including aligned text across all suppliers.

K O'Connor advised ESBN have no issues with the conditions outlined.

C McGowan asked for confirmation if a single site could be switched, and K O'Connor confirmed it would be possible.

J O'Dwyer advised it has been confirmed implementation in 2027 is acceptable in response to question posed by Electric Ireland as long as there is a process for these customers to request a smart meter.

### **Discussion on MCR1238**

D McBride asked to ensure feedback from Electric Ireland has been considered and if there is a view on the value threshold to be issued to the customer.

J O'Dwyer advised this would be reviewed by CRU in collaboration with ESBN

I Mullins raised again the question of when implementation would begin to allow suppliers time to process





data and also a timeframe where the data can flow over a specific period and not all at once.

K Tobin advised this was recorded in the feedback and advised ESBN will be flexible in issuing the data.

D McBride asked for confirmation on if the communications feedback is also being considered.

K Tobin confirmed it is and also that supplier communications to customers could also be issued.

I Mullins advised the communications issued on the ESBN website to date are not sufficient for BGE and more information for customers would be required.

A Keoghan also supports this view on behalf of Energia.

I Mullins raised that the AMI patching is almost standardizing the negative impact on customers and given the impact it is not clear why vendor support can't be obtained outside working hours.

K Tobin advised the feedback provided above will be taken into consideration.
