4. CRU Update

Feedback received on New Entrant Strategy is being reviewed and each Market Participant will receive a response. It is planned to circulate an updated version with tracked changes within the next week and the updated version to go for approval at the February IGG.

I Mullins asked for an update on submitted query relating to AMI Outage, R Hassett advised a response will issue in due course.

A vote was called to approve DR/MCR1234 – This DR/MCR was not approved at this time.

D McBride advised Electric Ireland would not be able to approve DR/MCR1234 at this time.

J Gregory also highlighted issues with data available on MCC02 profiles who were previously MCC03.

K O'Connor provided further information and advised NSH63 does have an RMCode and can be made identifiable to Market Participants.

I Mullins agrees that a further understanding of the mechanics is needed before a vote is taken.

J Burke also highlighted the importance of ensuring an acceptable tariff is made available.

C McGowan asked if there would be a difference in standing charge moving from MCC03 to MCC02.

C Leen advised that there is no difference.

Market Participants advised a TWG will be needed for further information on DR/MCR1234. Caoimhe McWeeney enquired about next steps.

Action 1171 has been raised to arrange a TWG on DR/MCR1234 and has been closed with TWG scheduled for 29th January 2025.

A Coppinger followed up on a query raised via email to RMDS around weather events impacting re-energisations.

R Hassett advised a call could be arranged to review the Working Practice 35 and the measures in place for weather events.

C McWeeney requested that this call be shared with other Market Participants.

J Burke queried if the process would be for ESNB to request that De-En requests are not issued.

R Hassett confirmed it would be similar to the email communication issued last week and that it is based of MET Eireann Weather Warnings.

I Mullins highlighted the importance of timing as there could be De-En requests sent prior to the email notification.

R Hassett advised that the communications would be sent as early as possible but a change in status of a weather event could cause a delay.

Action 1172 has been raised above to bring a refresher session on WP0035 to the next TWG and has been closed with TWG scheduled for 29th January 2025..
