**Background**

The smart metering programme has delivered the exchange of MCC01 single-phase, whole current, 24-hour meters.

ESBN have completed the procurement of Three Phase Meters and it is expected to be ready to deploy Q3 2023.

The initial scope will include MCC01 3 phase whole current meters <=50kVA only. MCC01 Whole Current 3 Phase total estate is 60,020 meters.

These Meters will be used to replace applicable MCC01 3 Phase Whole Current meters initially (like for exchange) with the remaining exchanges planned for Phase 3 of the Smart Metering Project.

Proposed Solution
<p>The proposed solution will adhere to the existing MCC01 exchange process that has been previously rolled out, the only meters in scope are Whole Current MCC01 sites with a 3-phase connection.</p> <p>A new RM Code is required for the 3 Phase Whole Current Meters; RM305. Only the whole current 3 Phase RM code to be designed for as part of this scope. An accompanying Code Change Request will be raised for the new RM along with this DR.</p>
