Secure Meters Seamless Solution


Proof of concept is progressing with volunteer suppliers.

HUB Relocation Project



- All MPs have completed the task of implementing the required firewall rules to connect to the new ROI Test HUB and all required connectivity checks have been performed by the Hub Relocation Project Team.
- Where connectivity issues arose, the relevant MPs have been contacted to arrange the required fixes. Your ongoing support with this would be appreciated.
- All MPs are also reminded that the firewalls to be implemented for the ROI Production
 Hub can be complete now. The deadline to have these firewall rules in place is the
 27th January 2023. Connectivity checks from MP's Production EMMAs to the ROI
 Production Hub will begin 30th January 2023.
- IPT is due to begin on the 9th January for all MPs that are included in this test phase.
- The Cutover and Hypercare plans are due to issue to all MPs the first week of February.
