<p><b>Background</b></p> <p>When there is a discrepancy in the reconciliation process the solution to identify the missing message(s) is quite cumbersome.</p> <p>Currently the 602 MM provides the type and count of messages sent/received between 03:00.00 am yesterday to 02:59:59 am today but no further details of the unique messages sent / received.</p>

Proposed Solution
<p>A new market message (603MM Daily Summary Transaction Details) will be created to provide Market Participants with the following</p> <ul style="list-style-type: none"> <li>The count of each Market Message Type will be provided for Market Participants convenience (similar to the 602MM).</li> <li>the Transaction Reference Number for each market message type contained in the overall 602MM count.</li> <li>A Multiple Identifier Number that will identify the number of 603MMs sent within the time period e.g. 1 of 1, 1 of 2 etc*.</li> </ul>

\*Note: Market Participants with very large market message volumes may receive multiple 603MMs for the same time period. This is to ensure that the 603MM size does not cause any processing difficulties. Where multiple 603MMs are being delivered this will be identified in each 603MM e.g. 1 of 2, 2 of 2 etc. This limit will be defined during implementation, but it is expected that most Market Participants will receive a single 603MM
