### 117R Valid Codes

#### Request Status

**Request Status: I = Initiate only allowed**

#### Valid Rejection Reasons

**IMS** - Invalid MPRN status

**SNK** - Supplier not known

**SNR** - Supplier Not registered to MPRN

**CIP** - CoS in progress

**IID** - Incorrect /Incomplete data

**CoLE** = 'N' and ESBN systems indicate no customer at the site (Updated at time of Harmonisation but not related for Harmonisation)

**MIC** - MIC Change detected.

**IMP** - Invalid MPRN (MPRN does not exist or is for a Grouped Un-metered site) or is invalid for this jurisdiction (Explanation expanded for Harmonisation v10.0)

**IA** – Invalid Action

A de-energisation NPA ( D02) request has been made for where either:

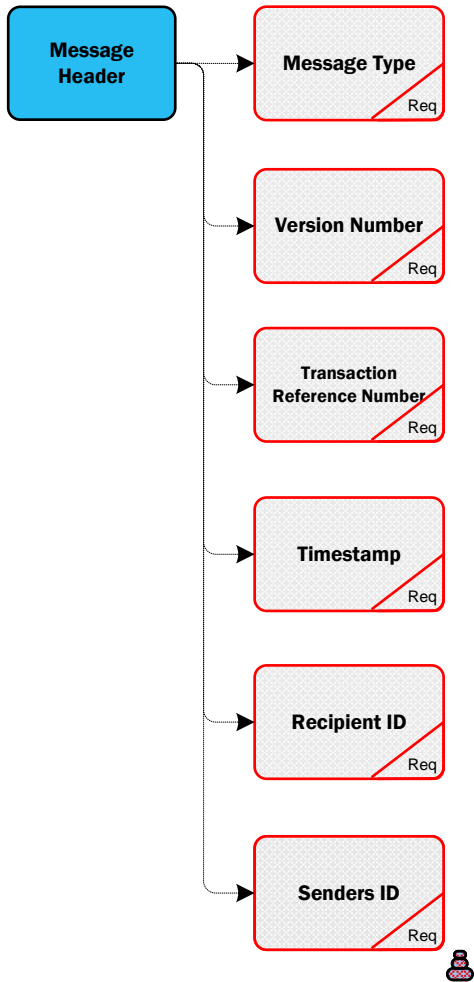
- A customer currently has a life support attribute or
- A customer currently has an Elderly attribute, and the request is received in the Winter period(Winter 1 Nov to 31st March).

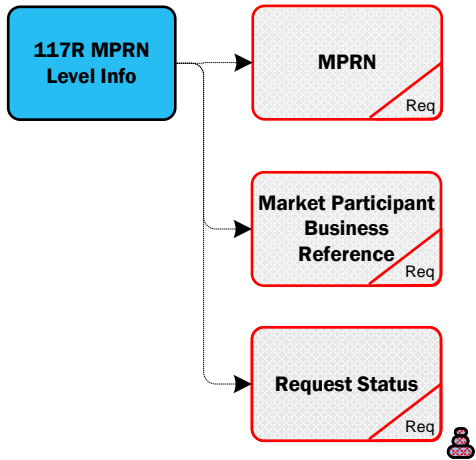

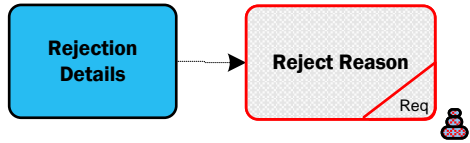

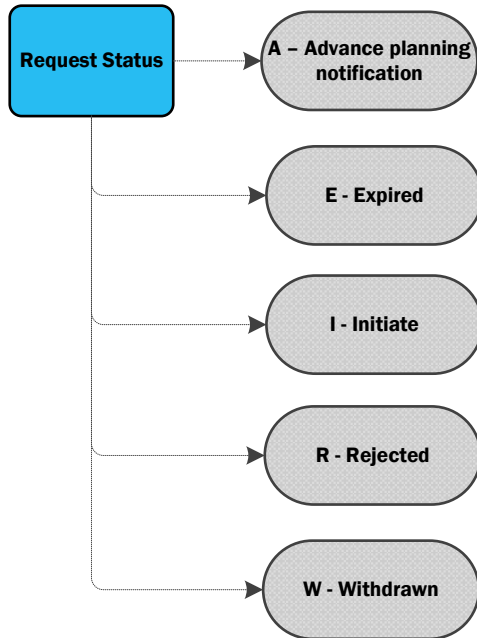
