MPD 06 also caters for a Registration that starts as Interval but either completes as Interval or Non Interval







## 3. Supplementary Information

#### 3.1 De-Registered Half Hourly Interval Sites

Where a site has previously been De-Registered, if this was a Half Hourly Interval site with Feasible Comms, then this will be registered as a Half Hourly Interval site upon energisation where Interval Smart Data Services have been requested.

Where a site has previously been De-Registered, if this was a Half Hourly Interval site with Feasible Comms, then this will be registered as a Non Interval site upon energisation where Non Interval Smart Data Services have been requested.
